



Legal Appendix

Jumpbooster Business Partner / Reseller Referral System

1. Definitions

In this Legal Appendix:

- **“ACL”** means the Australian Consumer Law contained in Schedule 2 of the *Competition and Consumer Act 2010 (Cth)*.
- **“Jumpbooster”** means Jumpbooster Pty Ltd (ABN 32104901751) and its related bodies corporate.
- **“Business Partner” / “Reseller”** means an approved business participating in the Jumpbooster Referral System.
- **“Customer”** means an end user who registers an account on the Jumpbooster website.
- **“Referral Link”** means a unique URL issued to a Business Partner for customer registration.
- **“Referral Code”** means a unique alphanumeric code issued to a Business Partner for customer registration.
- **“Store Credits”** means credits issued to a Business Partner under the referral system.

2. Business Partner Eligibility & Approval

Participation in the Jumpbooster Referral System is subject to approval by Jumpbooster.

Jumpbooster may, at its discretion:

- Approve or reject Business Partner applications
- Suspend or terminate participation at any time
- Impose conditions on continued participation

Nothing in this clause limits any rights or remedies available under the ACL.

3. Referral Linking & Attribution

- A Customer may only be linked to **one (1) Business Partner**.
- Referral linking occurs **only at the time of Customer registration**.
- Once linked, Customers cannot be reassigned to another Business Partner.

Jumpbooster is not responsible for missed referral credits resulting from:

- Failure to use a Referral Link or Referral Code at registration
- Errors or omissions by the Customer
- Registration completed outside approved referral processes

4. Store Credits

- Store Credits are earned only on eligible purchases made by linked Customers.
- Credit values may vary between promotions and are determined by Jumpbooster.
- Store Credits:
 - Accumulate in the Business Partner's store account
 - Are non-transferable
 - Are not legal tender

Jumpbooster may amend, suspend, or discontinue the Store Credit program at any time, subject to applicable law.

5. Credit Redemption

Store Credits may be redeemed as follows:

5.1 Product Redemption

- Store Credits may be applied toward the purchase of Jumpbooster products, including stock.

5.2 Cash Redemption

- Cash redemption is available at **50% of the credited value**.
- Payment timing and method are determined by Jumpbooster.

Store Credits do not accrue interest and are not trust monies.

6. Pricing, Promotions & Changes

- All prices, promotions, and credit values are subject to change.
- Promotional materials are indicative only and do not constitute a binding offer.
- Jumpbooster may withdraw or modify promotions at any time.

Nothing in this clause excludes guarantees provided under the ACL.

7. Marketing, Representations & Brand Use

Business Partners must:

- Comply with the ACL, including prohibitions on misleading or deceptive conduct
- Represent Jumpbooster products and promotions accurately
- Use Jumpbooster branding only with permission and in approved formats

Unauthorised brand use or misleading representations may result in termination.

8. Compliance With Laws

Business Partners are solely responsible for compliance with all applicable laws, including but not limited to:

- The *Competition and Consumer Act 2010 (Cth)*
- Australian Consumer Law
- State and Territory fair trading legislation

Jumpbooster is not liable for a Business Partner's failure to comply with legal obligations.

9. Limitation of Liability

To the maximum extent permitted by law:

- Jumpbooster excludes liability for indirect, incidental, or consequential loss
- Jumpbooster does not guarantee sales volume, referral numbers, or earnings
- Participation in the referral system is at the Business Partner's own risk

This clause does not exclude or limit liability that cannot be excluded under the ACL.

10. Termination

Jumpbooster may suspend or terminate a Business Partner's participation immediately if:

- These terms are breached
- Referral links or codes are misused
- Conduct damages or risks damaging Jumpbooster's reputation

Upon termination:

- Referral links and codes become invalid
 - Unredeemed Store Credits may be forfeited, subject to applicable law

Jumpbooster may amend this Legal Appendix at any time.

Continued participation after amendments take effect constitutes acceptance of the updated terms.

12. Governing Law & Jurisdiction

This Legal Appendix is governed by the laws of **Australia**, and the parties submit to the non-exclusive jurisdiction of the courts of the relevant Australian State or Territory.
